The Mortgage Society of Finland's bank subsidiary Suomen AsuntoHypoPankki Oy raises its Hypo Prime rate by 0.25 percentage points to 1.25 percent. The increase is based on the development of general market rates.

The rate change is effective as of 19 May 2023. In practice, only Group's deposit clients whose deposits have Hypo Prime as the reference rate will be affected.
